**Dear Parents,**

Thank you so much for your continued support in bringing your children to enjoy the activities at Evington Youth Club. Your involvement is what helps us make a difference in the lives of so many young people in our community.

As you may know, EYC is a registered charity, and about three years ago, parents agreed that it would be reasonable to request a small donation of **£2 per child per session** - with exceptions for parents on benefits or facing financial difficulties. These contributions have helped us keep the club running, but with rising costs and growing ambitions to improve the club, we're reaching out to you for additional support.

We're also pleased to inform you that, as a registered charity, EYC can claim **25% back from the Government** on all donations through Gift Aid. While we haven't done this in the past, we'd like to start claiming from the beginning of next year. To do so, we need parents who are taxpayers to sign the attached form, confirming that they're happy for us to claim Gift Aid on their donations and that they've paid the equivalent in tax over the past year. This small action from you can make a big impact on our funding!

To help us meet the increasing needs of the club, we are considering a slight increase to **£3 per child per session** starting next year. Alternatively, for those who would prefer the convenience of a bank transfer instead of bringing cash each time, we suggest a **monthly donation of £10 per child per activity**. This provides a hassle-free way to support the club, and it's entirely up to you which method works best for your family.
